# IDAHO'S TRANSPORTATION INFRASTRUCTURE: MOVING IDAHO FORWARD

## **GROUP OF 11 PUBLIC/PRIVATE SPONSORS**

A diverse group of transportation stakeholders selected IPI to conduct an independent analysis of Idaho's infrastructure needs and identify funding and financing alternatives to improve the state and local transportation system.

The report estimates an additional \$236.5 million per year in revenue is needed to meet preservation and restoration goals across the state, as well as \$5.3 million per year to maintain existing transit equipment and infrastructure. IPI's researchers note that unmet needs and deferred maintenance create a compounding effect, making the funding requirement significantly larger in the future.

Moving Idaho Forward offers decision makers a range of alternatives to reduce the funding gap, including modifying current user fees, establishing new user fees, adjusting statewide and local funding, exploring financing opportunities, and expanding transportation modes. Overall, the report concludes not only that Idaho's transportation system (beyond just roads and bridges to include transit, bicycle, and pedestrian infrastructure) is essential to a vibrant economy, but also that revenue instability hinders the ability of the state to keep systems in good repair and prevents any expansion efforts or significant operational changes. Beyond the written report, IPI created a dynamic financial model and an interactive map of policy alternatives used in all 50 states.

# NEW PATH COMMUNITY HOUSING EVALUATION: YEAR 1

### CITY OF BOISE

New Path Community Housing is a 40-unit, single site, Housing First project in Ada County, Idaho. Interim Director Vanessa Fry's initial feasibility study determined the potential to create the project. New Path's evidence-based program is designed to address specific issues related to chronic homelessness including high utilization of emergency medical and detox services, frequent contact with the criminal justice system, and compromised overall personal well-being.

As program evaluator, Idaho Policy Institute oversees all evaluation activities and works closely with New Path partners to design data collection strategies, monitoring, IPI's first annual evaluation found the impact of New Path to include:

- A 63% decrease in utilization of emergency services
- Total annual savings/cost avoidance of \$1,381,386
- An increase in overall resident well-being

and reporting for this program. "Being involved with this project is something that the institute values and we are honored to have served as the evaluator for its first year," says Fry, "It's not often academics have the opportunity to see their research put into action so, personally, being part of this project since its inception and now being able to engage in its evaluation has been a highlight of my career."

# ADVANCED OPPORTUNITIES PROGRAM EVALUATION



### IDAHO STATE BOARD OF EDUCATION


The Idaho State Legislature created the Advanced Opportunities (AO) Program in 2011. The AO program authorizes up to \$4,125 for each student in grades 7-12 to pay for AO courses. These include dual credit and overload courses as well as AP, ID, CLEP, and CTE exams.

The Idaho State Board of Education chose IPI to evaluate the AO Program's use of funds, program design, and program effectiveness. IPI analyzed enrollment and spending data collected by the Idaho Department of Education. IPI also conducted an online survey and in-depth interviews with AO personnel.

### **Key Findings:**

- Idaho spent \$19.2 million to fund AO courses in SY 2018-19
- 37,268 students used AO funding
- 72% of AO funding went toward dual credit courses
- Almost all districts and charter schools across the state offer dual credit courses
- AP exams are less likely to be offered in rural areas

Students across the state used AO Program funds regardless of rurality or region. AO personnel indicated the financial support provides equitable access to AO courses statewide, increases student confidence, and individualizes learning.

## **CAPSTONE PROJECTS**

The culminating experience for MPA students is the MPA Capstone class. This class provides students with the opportunity to partner with clients, enabling real life experience working in public policy and administration research. Each semester, the IPI director works with these students, supporting their research with clients at local, state, and national organizations. In 2020 students conducted interviews and surveys, analyzed datasets, and utilized case studies to address issues including suicide, the COVID-19 pandemic, and bullying, harassment, and discrimination.
